

ARBONNE SPECIAL DELIVERY PROGRAM AGREEMENT

The Arbonne Special Delivery Program ("Program") is a standing order that is automatically shipped to an Arbonne Independent Consultant or Client (collectively "Participant") each month. Program Participants agree as follows:

1. Participants specify those products and the respective quantities of each product they wish to have automatically shipped each month by listing them on the front of this Agreement.
2. By signing the Arbonne Special Delivery Application, the Participant authorizes Arbonne to automatically charge his/her credit card for each Arbonne Special Delivery order plus shipping, handling, and applicable sales tax. Credit cards may be charged up to seven days prior to the shipping date. Participant agrees to hold Arbonne harmless for all damages, including but not limited to special, consequential, direct and/or indirect, resulting from any wrongful charge to Participant's account.
3. Arbonne Special Delivery orders are normally shipped on or about the day of the month selected to ship (between the 5th and the 25th).
4. Program orders must be a minimum of \$20.00 at Suggested Retail Price. Participants may change their Arbonne Special Delivery order, payment method, and delivery address by submitting written notice of changes to Arbonne at least 14 days prior to the next scheduled Arbonne Special Delivery ship date. Change requests received within 14 days of the next scheduled ship date will take effect in the month after the next scheduled shipment date.
5. Arbonne reserves the right to change the prices of any products in its product line, and to discontinue any products in its line, including those products selected as part of an Arbonne Special Delivery order. Announcements of price changes will be issued at least 30 days before going into effect. Arbonne will continue to ship selected products following a price change unless the Participant change his/her order at least 14 days before the next scheduled shipment date. Arbonne further reserves the right to change shipping charges upon 30 days advance notice. Arbonne will not issue advance notice of discontinued products. Increases in sales tax charges are subject to change without notice.
6. Arbonne may terminate this Agreement without notice if the credit card(s) to which a Participant has authorized charges becomes expired, cancelled, or charges declined by the bank issuing the card for any reason.
7. Participant may cancel his/her participation in the Program at any time by submitting written cancellation to Arbonne. Written cancellation must include Participant's printed name, signature, address, Arbonne ID, and notice of cancellation. Cancellation will be effective in the calendar month in which it is received by Arbonne so long as the credit card has not already been charged for that month's order. If written cancellation notice is received after the account has been charged, the cancellation will become effective in the following month.
8. Arbonne's standard return and refund policies apply to Arbonne Special Delivery orders.
9. Arbonne reserves the right to amend the Program requirements at its sole discretion upon 30 days advance notice.
10. Arbonne may discontinue the Program without advance notice. For Arbonne Consultants, this Agreement does not supersede or modify the terms and conditions of their Arbonne Independent Consultant Application & Agreement or Arbonne's Policies and Procedures.

NOTICE OF RIGHT TO CANCEL

Date of Transaction _____

You may CANCEL this transaction, without any penalty or obligation, within THREE BUSINESS DAYS from the date on which it was executed (FIVE DAYS for Alaska residents). If you cancel, any payments made by you under the contract or sale, and any negotiable instrument executed by you will be returned within 10 BUSINESS DAYS following receipt by Arbonne of your cancellation notice. If you cancel, you must make available to the seller at your residence, in substantially as good condition as when received, any goods delivered to you under this contract or sale, or you may, if you wish, comply with the instructions of the seller regarding the return shipment of the goods at the seller's expense and risk. If you do make the goods available to the seller and the seller does not pick them up within 20 days of the date of your Notice of Cancellation, you may remain or dispose of the goods without any further obligation. If you fail to make the goods available to the seller, or if you agree to return the goods to the seller and fail to do so, then you remain liable for performance of all obligations under the contract. To cancel this transaction, mail or deliver a signed and dated copy of this Cancellation Notice, or any other written notice, to Arbonne, Attn: Customer Service, 4550 Excel Pkwy, Suite 600, Addison, TX 75001, or send a fax to Arbonne at 1.866.634.1151 NOT LATER THAN MIDNIGHT of the third business day following the date on which you executed the Agreement.
